



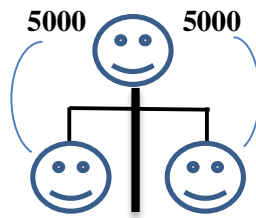

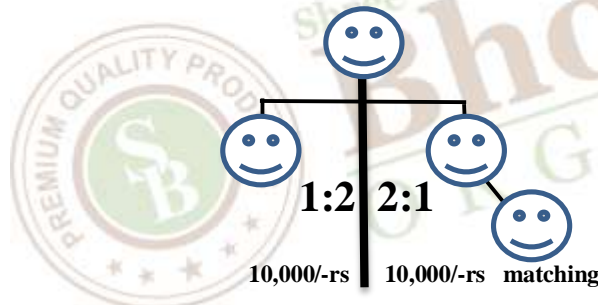

  - To register for OFC or KSP, The Company must fully explain its business model before registering.
  - Your profile KYC must be submitted to receive KSP unit income.
  - Re-Purchase Income
  - Royalty Bonus
  - Secure Bonus
- To get this income, you need to make a purchase of **700 BV** every month.
- All KSP/OFCs Should provide complete information about the products sold to farmers and get them used in their fields.
  - To have your purchase delivered to your home, you must fill in the correct and complete address in your business profile.
  - Your purchased item will be delivered to your nearest transport hub as per the parcel transport rules.
  - The commission you receive will be transferred to your account after taking 2% TDS and 3% handling charge.
  - All KSP owners have to deposit any business amount coming from their business or their group directly into the company account.
  - It is illegal to use the name of company to obtain money from the market or transfer it to your account using false promises of false commitments. If you are caught doing so, legal action will be taken.
